Police – Bob Ludt, Chief:

(2) Ms. Fabrizio then read from our zoning regulations and asked if they had applied for a permit for the changes. Mrs. Brown said that per our attorney they didn't need to apply because the restaurant was part of the golf course and the blueprint of the building has not been changed. (3) Ms. Fabrizio asked if they have applied for a liquor license. Mrs. Brown stated they already have a liquor license that is in safekeeping with the State of Ohio.
