Tom Shay gave an update on the financial situation, it's been widely reported that on February 14th paychecks did not clear the bank for a portion of the employees because there was no money in the bank. There is an ongoing investigation and audit of the township to find out where the money went. At that time the Board of Trustees requested from the Auditor of States office that a financial distress calculation be performed to determine if the government qualifies for any of the three financial distress categories. They also requested that tax advances be given from the County Auditor for taxes that have been paid but not yet distributed to the government. They have received those tax advances and those advances have been paid out to meet obligations of the government. We have found out in the last couple of weeks when collecting unpaid invoices and calculating the amounts still outstanding in unpaid bills, we think it's at least 1.3 million is still unpaid as of today and on tax settlement we received just over \$100,000.00. Right now, we have that \$100,000.00 in the bank account and are looking to get a tax anticipation note which can only be up to one half of our next anticipated collection. We normally would collect around a half a million dollars so \$250,000.00 is the loan we're looking to obtain. The situation we are in is having the \$100,000.00 for settlement and getting a loan for \$250,000.00 to make it all the way to September. So that is what we are faced with and what we have communicated with the Trustees on we know as of the first 22 days we have been working on this. I think as time goes on that we're going to learn more and there are a lot more questions.
